- 6. Security and Safety incidents should be recorded and subject to full analysis resulting in appropriate corrective measures to improve the security and safety level of the company.
- 7. The professionalism, integrity and skills of security employees or subcontractors working on behalf of the company must be exemplary and rigorously assessed.
- 8. Sound awareness and training of employees and subcontractors are key to ensure the correct understanding and the ability to apply those procedures on a daily basis.
